### Reception Hours

holidays. For after hours emergencies  
please call 0402 415 319.

### Speed Limit

10 kmph is the speed limit within the Park.

### Boom Gates

Only one car can go through at a time.  
Please validate each vehicle as you enter  
the Park.

### Parking

Please do not park on a site not assigned  
to you. All cars, trailers & boats need to be  
contained to your site. Should you need  
extra parking, please see the Park Map for  
where else you can park.

### Sites

All RV's are to be parked with the front  
towbar facing the roadway per fire  
regulations. 15amp power leads are to be  
used to connect to the power head. If you  
are on a grass site, please help us with  
keeping the grass healthy by keeping mat  
usage to a minimum.

### Appliances

For safety reasons, please ensure all  
electrical goods such as air conditioners,  
stoves etc are switched off when you are  
not in your accommodation.

### Fire Pits

Site Fire Pits are available for use outside  
of Fire Danger Season only as per SA  
CFS. Please see our friendly staff prior to  
lighting your fire pit to read and sign our  
fire pit policy. Do not remove wood from  
the adjacent bushland reserve.

A communal fire pit is also available for  
use outside of Fire Danger Season only  
as per SA CFS. Wood is supplied for your  
enjoyment. If you would like the fire pit  
lit, please ask one of our friendly team  
members.

### BBQs

BBQs are cleaned regularly but please  
help us keep them as tidy as possible and  
clean up after use.

### Rubbish

Bins are provided for your convenience  
throughout the Park.

### Noise

After 10pm noise should be kept to a  
minimum, please be respectful of other  
guests.

### Visitors

Guests' visitors are more than welcome.  
Please sign them in at Reception.

### Behaviour

Anti-social behaviour is not ok and may  
result in immediate eviction from the Park.

### Smoking & Vaping

Smoking and the use of e-cigarettes is not  
permitted in Park facilities, including within  
5 meters of any facility building entrances.  
Smoking is also not permitted in any of  
the cabins. Please use the cigarette bins  
provided.

### Amenities

Amenities are cleaned daily for an hour.  
Cleaning times are displayed at the  
entrance.

### Pets

Pets are welcome on Powered Sites and  
in dedicated Pet Cabins in accordance  
with the Pet Guide and at the Park Team's  
discretion.

All other cabins and facilities are not to be  
entered by pets. Leads are to be worn by  
pets at all times and owners should always  
accompany pets. Please clean-up after  
your pets and attempt to limit constant  
or excessive noise. Failure to adhere to  
the Pet Guide and Pet Policy may result  
in guests being asked to leave the Park  
without a refund.

Dedicated Pet Cabins are identified as  
such by name, and are limited to 2 pets.
